Terms and Conditions

- Family and friends of the Client shall be permitted to photograph the wedding as long as they shall not interfere with the Photographer's duties and/or equipment.
- Deposit and Payment. The Client shall make a non-refundable deposit to retain the Photographer to perform the services specified herein. The deposit to book the date disclosed shall be in the amount of **\$225.00**. The final payment, in the amount of **\$225.00**, shall be due in full the night of the wedding rehearsal, or risk voiding contract. With the deposit paid the Client receives a credit for fifty (50) free 4x6 prints usable at any time (Sales tax and shipping costs shall apply). In addition, the Client may use up to three (3) pre-wedding sessions for the purpose of engagement and/or bridal shoots. Sessions are subject to Photographers schedule. Photographer will be available as needed during the wedding day; no hourly rates apply.

- Cancellation. If the Client shall cancel this Agreement thirty (30) or more calendar days before the original wedding date, as defined herein, a new date can be scheduled within six (6) months of the original date, without the loss of the paid deposit. If Client shall cancel within thirty (30) days of the wedding date, contract will be voided and rights to deposit lost. Rescheduled events are subject to Photographer's schedule.
- Photographic Materials. All photographic materials, including but not limited to original images, proofs, and previews, shall be the exclusive property of the Photographer. The Photographer shall make proofs and previews available to the Client for the purpose of selecting photographs, but such proofs and previews will be watermarked as "PROOF", the image number, and Photographer's web site and/or logo. Proofs are not to be reproduced without the watermarks defined above or without written consent by Photographer in advance. Proofs will be made available by one or more of the following means: DVD Slideshow, PC CD, and/or Photographer's online website galleries.
- Copyright and Reproductions. The Photographer shall own the copyright in all images created and shall have the exclusive right to make reproductions. The Photographer shall only make reproductions for the Client or for the Photographer's portfolio, samples, self-promotions, entry in photographic contests or art exhibitions, editorial use, or for display within or on the outside of the Photographer's studio and/or web site.. If the Photographer desires to make other uses, the Photographer shall not do so without first obtaining the written permission of the Client.
- Client's Usage. The Client is obtaining prints for personal use only, and shall not sell said prints or authorize any reproductions thereof by parties other than the Photographer.
- Failure to Perform. If the Photographer cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event the Photographer fails to perform for any other reason, the Photographer shall not be liable for any amount in excess of the retail value of the Client's order.
- Photographer. The Photographer may substitute another photographer to take the photographs in the event of illness or family emergency.. In the event of such substitution, Photographer warrants that the photographer taking the photographs shall be a competent professional.
- Inherent Qualities. Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
- Photographer's Standard Price List. The charges in this Agreement are based on the Photographer's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed. Shipping costs and minimum orders will be listed with the displayed price list.
- Miscellany. This Agreement incorporates the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this Agreement. This Agreement shall be governed by the laws of the State of Missouri.

The parties have read the agreement, agree to all its terms, and acknowledge receipt of a complete copy of the Agreement signed by both parties. Each person signing as Client below shall be fully responsible for ensuring that full payment is made pursuant to the terms of this Agreement.
